"AGREEMENT"

For and in consideration of participant's registration with PAVILION LLC, (hereafter Pavilion), and being permitted to participate (individually or member team player) in any way in the sports, entertainment offerings and/or event activities of the Pavilion, ("Activity"), I, for myself for personal representatives, executors, administrators, assigns, heirs, and next of kin:

1). ACKNOWLEDGE, agree and represent that I understand the nature of the Pavilion Activity and that I am qualified, in good health and in proper physical condition to participate in such Activity. I further agree and warrant that if any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

2). FULLY UNDERSTAND that: (a) Such Activity involve risks and dangers of property damage or serious personal bodily injury, including permanent disability, partial or total paralysis, and death ("Risks"); (b) These Risks and dangers may be caused by my own condition in which the Activity takes place, or the negligence of the "RELEASEES" named below; (c) There may be other Risk and social and economic losses either not known to me or not readily foreseeable at this time. (d) That the sports of indoor soccer & lacrosse, in-line hockey & skating, flag football, dodgeball, basketball, volleyball, and other similar sports and/or activities incidental thereto, involve inherent risks. (e) That the use of indoor hockey rinks, sport court playing surfaces, artificial turf surfaces, associated goals, access doors, etc. and related premises involve inherent risks from the conditions and use of said facilities and acknowledges and understand that included within the scope of this waiver and release is any cause of action arising from the performance, or failure to perform maintenance, inspection, supervision or control of said areas and for the failure to warn of dangerous conditions existing at said facilities, for negligent selection of certain RELEASEES, or negligent supervision or instruction by RELEASEES. I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITIES for losses, costs and damages I incur as a result of my participation OR that of the minor in the Activity.

3). HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE the Pavilion, their respective administrators, directors, agents, officers, members, volunteers, employees, referees, officials, coaches, other participants, member teams, any

sponsors, advertisers, and if applicable, owners, lessors, lessees, suppliers/vendors, caterers of the premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "RELEASEES" or otherwise, including negligent rescue and/or first aid operations. And further, I AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, I, or anyone on my behalf, makes a claim against any of the RELEASEES, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

4). HEREBY ACKNOWLEDGE AND ALLOW that audio and/video recording equipment may be in use at any time and that no expectation of privacy should exist inside the Pavilion facility and/or on the outside premises. IN ADDITION, I allow Pavilion to make and/or use in whole or in part, photographs, videos, written extractions, and voice recordings of the myself, the participant, without enumeration, for whatever reason, including but not limited to: promotional or training materials, security evidence, retail products, etc.

5). HERBY ACKNOWLEDGE AND AGREE that I may also enter into a contract that requires payment per the one-time facility membership fees, individual participant and team league fees for a sport and/or possible individual event fees. A \$ 25.00 fee will be charged on all returned checks. At it's discretion, Pavilion may issue refunds or credits prior to the registration deadline. After the registration deadline, Pavilion shall not be obligated to issue refunds or credits under any circumstances.

6). HEREBY FULLY ACKNOWLEDGE that I have read, understand and that I will abide by the Pavilion facility rules, it's Code of Sportsmanship and Conduct and the Michigan Public Act regarding roller skating activities.

I have read this AGREEMENT, fully understand it's terms, understand that I have given up substantial rights by signing it and have signed it freely and without inducement or assurance of any nature and intend it to be a COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
